20-221-03 A bill to be entitled 1 2 An act relating to trust funds; creating the Rape Crisis Program Trust Fund within the 3 4 Department of Health; providing for the use of 5 funds and the source of funds; requiring the Department of Health to adopt rules for 6 7 distributing moneys in the trust fund; providing for review and termination or 8 9 re-creation of the trust fund; providing a contingent effective date. 10 11 12 Be It Enacted by the Legislature of the State of Florida: 13 14 Section 1. Rape Crisis Program Trust Fund. --(1) The Rape Crisis Program Trust Fund is created 15 16 within the Department of Health for the purpose of providing 17 funds for rape crisis centers in this state. Trust fund moneys shall be used exclusively for the purpose of providing 18 19 services for victims of sexual assault. Funds credited to the trust fund consist of those funds collected as an additional 20 21 court assessment in each case in which a defendant pleads 22 guilty or nolo contendere to, or is found guilty of, 23 regardless of adjudication, an act of sexual battery as 24 defined in section 794.011, Florida Statutes. 25 (2) The Department of Health shall establish by rule criteria for distributing moneys from the trust fund to rape 26 27 crisis centers. (3) In accordance with Section 19(f)(2) of Article III 28 29 of the State Constitution, the Rape Crisis Program Trust Fund 30 shall be terminated on July 1, 2007, unless terminated sooner. Before its scheduled termination, the trust fund shall be 31 1
