(1) The Court Education Trust Fund within the state courts system, FLAIR number 22-2-146, which is to be 23 terminated pursuant to Section 19(f), Article III of the State 24 25 Constitution on November 4, 2004, is re-created. 26 (2) All current balances of the trust fund are carried 27 forward, and all current sources and uses of the trust fund 28 are continued. 29 Section 2. This act shall take effect November 4, 30 2004. 31
