30	(a) The department shall develop a Live the Dream license
31	plate as provided in this section. The word "Florida" must
32	appear at the top of the plate, and the words "Live the Dream"
33	must appear at the bottom of the plate.
34	(b) The annual use fees shall be distributed to the Dream
35	Foundation, Inc., which may use up to 25 percent of the proceeds
36	to market the organization's concept and the license plate. The
37	remaining funds shall be used in the following manner:
38	1. Thirty percent shall be distributed as grants to dental
39	clinics that provide affordable or free dental services to
40	underprivileged persons in areas where adequate dental treatment
