Section 26. Section 440.34, Florida Statutes, is amended to read:

440.34 Attorney's fees; costs.--

(1) A fee, gratuity, or other consideration may not be paid for benefits secured ~~services rendered~~ for a claimant in connection with any proceedings arising under this chapter, unless approved as reasonable by the judge of compensation claims or court having jurisdiction over such proceedings. For purposes of this section, the term "benefits secured" shall reflect the following: Except as provided by this section ~~subsection~~, any attorney's fee approved by a judge of compensation claims for benefits secured for ~~services rendered~~ to a claimant shall be ~~must~~ equal to 20 percent of the first \$5,000 of the amount of the benefits secured, whether ordered or agreed to by the parties, and 15 percent of the ~~next \$5,000~~

6 approve an attorney's fee that may not exceed \$2,500, based on
7 a maximum hourly rate of \$150 per hour, if the judge of
8 compensation claims expressly finds that the fee, based upon
9 the total benefits secured, fails to fairly compensate the
10 attorney and the benefits secured are less than \$10,000. In a
11 proceeding in which a carrier or employer denies that an
12 injury occurred for which compensation benefits are payable
13 and the claimant prevails on the issue of compensability, in
14 lieu of an attorney's fee equal to 15 percent of the benefits
15 secured, the judge of compensation claims may award an
16 attorney's fee that may not exceed \$2,500, based on a maximum
17 hourly rate of \$150 per hour, if the judge of compensation
18 claims expressly finds that the attorney's fee, based on the
19 benefits secured, fails to fairly compensate the attorney and

10 (2) In awarding a reasonable claimant's attorney's
11 fee, the judge of compensation claims shall consider only
12 those benefits secured by the attorney to the claimant that
13 the attorney is responsible for securing. An attorney is not
14 entitled to attorney's fees for representation in any issue
15 that was ripe, due, and owing and that reasonably could have
16 been addressed during the pendency of other issues for the
17 same injury. The amount, statutory basis, and type of benefits
18 obtained through legal representation shall be listed on all
19 attorney's fees awarded by the judge of compensation claims.
20 For purposes of this section, the term "benefits secured"
21 ~~means benefits obtained as a result of the claimant's~~
22 ~~attorney's legal services rendered in connection with the~~
23 ~~claim for benefits. However, such term does not include future~~
24 ~~medical benefits to be provided on any date more than 5 years~~
25 ~~after the date the claim is filed.~~

26 (3) If any party ~~the claimant~~ should prevail in any
27 proceedings before a judge of compensation claims or court,
28 there shall be taxed against the nonprevailing party ~~employer~~
29 the reasonable costs of such proceedings, not to include ~~the~~
30 attorney's fees ~~of the claimant~~. A claimant shall be
31 responsible for the payment of her or his own attorney's fees,

2 | reasonable attorney's fee from a carrier or employer:

3 | (a) Against whom she or he successfully asserts a
4 | petition for medical benefits only, if the claimant has not

6 | disability, permanent impairment, wage-loss, or death
7 | benefits, arising out of the same accident;

8 | (b) In any case in which the employer or carrier files
9 | a response to petition denying benefits with the Office of the
10 | Judges of Compensation Claims and the injured person has
11 | employed an attorney in the successful prosecution of the
12 | petition;

13 | (c) In a proceeding in which a carrier or employer
14 | denies that an accident occurred for which compensation

20 | Regardless of the date benefits were initially requested,
21 | attorney's fees shall not attach under this subsection until

25 | (a), (b), (c), and (d), the judge of compensation claims must
26 | only consider only such benefits and the time reasonably spent
27 | in obtaining them as were secured for the claimant within the
28 | scope of paragraphs (a), (b), (c), and (d).~~

2 (5) If any proceedings are had for review of any
 3 claim, award, or compensation order before any court, the
 4 court may award the injured employee or dependent an
 5 attorney's fee to be paid by the employer or carrier, in its
 6 discretion, which shall be paid as the court may direct.

7 (6) Retainer agreements or contracts of representation
 8 may not be submitted to a judge of compensation claims for
 9 approval except in conjunction with an appropriate motion for
 10 approval of a specific fee following the securing of a
 11 specific benefit or benefits. A judge of compensation claims
 12 may not prospectively approve a contract of representation
 13 prior to the securing of the benefit. A judge of compensation
 14 claims may not enter an order approving the contents of a
 15 retainer agreement that permits the escrowing of any portion
 16 of the employee's compensation until benefits have been
 17 secured.

18 (7) The judge of compensation claims shall not approve
 19 a compensation order, a joint stipulation for a lump-sum
 20 settlement, a stipulation or agreement between a claimant and
 21 his or her attorney, or any other agreement related to
 22 benefits under this chapter which provides for an attorney's
 23 fee in excess of the amount permitted by this section.
