SUMMARY ANALYSIS

The Key Largo Wastewater Treatment District is an independent special district that provides wastewater treatment in Key Largo. A special provision in the district's charter requires the district to comply with the Administrative Procedure Act.

This bill removes the special requirement that the Key Largo Wastewater Treatment District comply with the Administrative Procedure Act.

This bill does not appear to have a fiscal impact on state government. This bill appears to have an unknown but positive recurring fiscal impact on the district.

B. EFFECT OF PROPOSED CHANGES:

Background

The Key Largo Wastewater Treatment District is an independent special district, created in 2002 by ch. 2002-337, L.O.F., and charged with constructing and operating a wastewater treatment system for Key Largo.¹ The Key Largo Wastewater Board is responsible for ensuring that state-mandated advanced wastewater treatment standards are achieved in Key Largo by 2010.² The five member governing board is elected.

The Administrative Procedure Act ("APA"), ch. 120, F.S., is applicable to state executive branch agencies and departments, regional planning agencies, and multicounty special districts in which a majority of the governing board consists of nonelected persons.³ The APA is only applicable to other entities, such as the Key Largo Wastewater Treatment District, if provision is made for applicability of the APA in general or special law applicable to the district. Section 4(2)(b) of the current charter for the district requires it to comply with the APA. Typically, single-county districts like the Key Largo Wastewater Treatment District are not required to comply with the APA.

Proposed Change

This bill amends the charter of the Key Largo Wastewater Treatment District to remove the requirement that the Key Largo Wastewater Treatment District comply with the APA.

C. SECTION DIRECTORY:

Section 1 amends the charter of the Key Largo Wastewater Treatment District to provide that the district is not subject to the APA, ch. 120, F.S.

Section 2 provides an effective date of upon becoming law.
