A bill to be entitled
An act relating to career service exemptions;
amending s. 110.205, F.S.; deleting positions
related to the Correctional Educational Program
within the Department of Corrections; deleting
superintendent and assistant superintendent
positions and adding the positions of colonel
and major within the Department of Corrections;
providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Paragraphs (d) and (m) of subsection (2) of
section 110.205, Florida Statutes, are amended to read:

110.205 Career service; exemptions.--

(2) EXEMPT POSITIONS.--The exempt positions that are
not covered by this part include the following:

(d) All officers and employees of the state
~~universities and the Correctional Education Program within the~~
~~Department of Corrections,~~and the academic personnel and
academic administrative personnel of the Florida School for
the Deaf and the Blind. In accordance with the provisions of
s. 1002.36, the salaries for academic personnel and academic
administrative personnel of the Florida School for the Deaf
and the Blind shall be set by the board of trustees for the
school, subject only to the approval of the State Board of
Education. ~~The salaries for all instructional personnel and~~
~~all administrative and noninstructional personnel of the~~
~~Correctional Education Program shall be set by the Department~~
~~of Corrections, subject to the approval of the Department of~~
~~Management Services.~~

1 (m) All assistant division director, deputy division
2 director, and bureau chief positions in any department, and
3 those positions determined by the department to have
4 managerial responsibilities comparable to such positions,
5 which positions include, but are not limited to:

6 1. Positions in the Department of Health and the
7 Department of Children and Family Services which, ~~and the~~
8 ~~Department of Corrections that~~ are assigned primary duties of
9 serving as the superintendent or assistant superintendent, ~~or~~
10 ~~warden or assistant warden~~, of an institution;

11 2. Positions in the Department of Corrections which
12 ~~that~~ are assigned primary duties of serving as the warden,
13 assistant warden, colonel, or major of an institution or which
14 are assigned primary duties of serving as the circuit
15 administrator or deputy circuit administrator;

16 3. Positions in the Department of Transportation which
17 ~~that~~ are assigned primary duties of serving as regional toll
18 managers and managers of offices as defined in s.
19 20.23(3)(d)3. and (4)(d);

20 4. Positions in the Department of Environmental
21 Protection which ~~that~~ are assigned the duty of an
22 Environmental Administrator or program administrator; and

23 5. Positions in the Department of Health which ~~that~~
24 are assigned the duties of Environmental Administrator,
25 Assistant County Health Department Director, and County Health
26 Department Financial Administrator.

28 Unless otherwise fixed by law, the department shall set the
29 salary and benefits of these positions in accordance with the
30 rules established for the Selected Exempt Service.

1 Section 2. This act shall take effect upon becoming a
2 law.
