Subsection (10) is added to section 13 14 288.1229, Florida Statutes, to read: 288.1229 Promotion and development of sports-related 15 16 industries and amateur athletics; direct-support organization; 17 powers and duties. --18 (10)(a) There is hereby created the Advisory Council 19 for a Fit Florida for the purpose of serving as an advisory 20 body to the Governor, the Legislature and the direct support organization to provide insight and expertise relating to 21 physical fitness and nutrition in the state. In order to 22 23 accomplish this purpose, the council shall do the following: 24 1. Advise the direct support organization on ways to 25 promote interest in the area of physical fitness and nutrition 26 and to provide assistance in such promotion; 27 2. Examine current physical fitness and nutrition programs available to the people of this state and recommend 28 29 to the direct support organization any coordination of 30 programs needed to prevent duplication of services. 31

for a term of 2 years, two for a term of 3 years, and two for 1 a term of 4 years. At the end of the respective terms of 2 3 office of the initial members, all succeeding appointments shall be for terms of 4 years. Members shall serve no more 4 5 than two consecutive 4-year terms. 6 5. All unexpired terms due to vacancy shall be filled 7 by the official who appointed the council member. 8 6. The council shall annually elect from the 9 membership one member to serve as chair of the council and one member to serve as vice chair. 10 7. The council shall meet no more than quarterly and a 11 12 majority of the council shall constitute a quorum for the transaction of business. 13 14 8. Members of the council shall receive no compensation but shall receive reimbursement for per diem and 15 travel expenses as provided in s. 112.061, Florida Statutes, 16 17 while in the performance of their duties. 18 (c) This subsection is repealed on July 1, 2008. 19 Section 2.
