A bill to be entitled  
An act relating to the Central Florida Regional  
Transportation Authority; amending s. 343.63,  
F.S.; revising membership of the governing  
board of the authority; providing an effective  
date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Subsections (2) and (3) of section 343.63,  
Florida Statutes, are amended to read:

343.63 Central Florida Regional Transportation  
Authority.--

(2) The governing board of the authority shall consist  
of five ~~11~~ voting members, ~~and 1 nonvoting member~~ as follows:

(a) The chairs of the county commissions of Seminole,  
Orange, and Osceola Counties or another member of the  
commission designated by the chair shall each serve as a elect  
~~a commissioner as that commissioner's~~ representative on the  
board. ~~The commissioner must be a member of the county~~  
~~commission when elected and for the full extent of his or her~~  
~~term. The terms of the county commissioners on the governing~~  
~~board of the authority shall be 2 years.~~

(b) The mayor ~~mayors of the cities of Altamonte~~  
~~Springs, Orlando, or a member of the Orlando City Council and~~  
~~Kissimmee, or a member of each city commission~~ designated by  
the each mayor, shall serve as a representative a term of 2  
years on the board for the full extent of his or her term.

~~(c) The Governor shall appoint five members to the~~  
~~board. Two of the members shall be residents of Orange County,~~  
~~one member shall be a resident of Seminole County, one member~~

1 ~~shall be a resident of Osceola County, and one member shall be~~  
2 ~~a resident of the City of Orlando. All five members shall~~  
3 ~~serve a term of 4 years.~~

4 (c)~~(d)~~ The Secretary of Transportation shall appoint  
5 the district secretary, or his or her designee, for the  
6 district within which the area served by the authority is  
7 located and this member shall be a voting ~~nonvoting~~ member.

8 (3) A vacancy during a term shall be filled ~~by the~~  
9 ~~respective appointing authority~~ in the same manner as the  
10 original appointment and only for the balance of the unexpired  
11 term.

12 Section 2. This act shall take effect upon becoming a  
13 law.

15 STATEMENT OF SUBSTANTIAL CHANGES CONTAINED IN  
16 COMMITTEE SUBSTITUTE FOR  
17 Senate Bill 2572

18 The CS amends s. 343.63, F.S., to change the membership of the  
19 governing board of the Central Florida Regional Transportation  
Authority from 11 members to 5 members as follows:

20 1. The chair of the county commissions of Seminole, Orange,  
21 and Osceola Counties or their designees will each serve as  
members for the term of their respective commission chairs.

22 2. One member must be the mayor of the city of Orlando, or a  
23 member of the Orlando City Council, as designated by the  
mayor, and serve for the full extent of his or her term.

24 3. One member will be the FDOT district secretary or his or  
25 her designee.
