Section 320.089, Florida Statutes, is amended to read: 18 19 320.089 Limited-issue specialty Members of National 20 Guard and active United States Armed Forces reservists; former 21 prisoners of war; survivors of Pearl Harbor; Purple Heart 22 medal recipients; special license plates; fee .--23 MEMBERS OF NATIONAL GUARD AND ACTIVE UNITED STATES (1)ARMED FORCES RESERVISTS; SURVIVORS OF PEARL HARBOR; PURPLE 24 25 HEART MEDAL RECIPIENTS.--(a) Each owner or lessee of an automobile or truck for 26 27 private use or recreational vehicle as specified in s. 28 320.08(9)(c) or (d), which is not used for hire or commercial use, who is a resident of the state and an active or retired 29 30 member of the Florida National Guard, a survivor of the attack on Pearl Harbor, a recipient of the Purple Heart medal, or an 31 1

active member of any branch of the United States Armed Forces 1 2 Reserve shall, upon application to the department, accompanied 3 by proof of active membership or retired status in the Florida 4 National Guard, proof of membership in the Pearl Harbor 5 Survivors Association or proof of active military duty in 6 Pearl Harbor on December 7, 1941, proof of being a Purple 7 Heart medal recipient, or proof of active membership in any branch of the Armed Forces Reserve, and upon payment of the 8 9 license tax for the vehicle as provided in s. 320.08, be 10 issued a license plate as provided by s. 320.06, upon which, 11 in lieu of the serial numbers prescribed by s. 320.06, shall be stamped the words "National Guard," "Pearl Harbor 12 13 Survivor, "Combat-wounded veteran, or "U.S. Reserve, as 14 appropriate, followed by the serial number of the license 15 plate. Additionally, the Purple Heart plate may have the words "Purple Heart" stamped on the plate and the likeness of the 16 17 Purple Heart medal appearing on the plate. (b) Notwithstanding any other provision of law to the 18 19 contrary, beginning with fiscal year 2002-2003 and annually thereafter, the first \$100,000 in general revenue generated 20 from the sale of license plates issued under this section 21 which are stamped with the words "National Guard," "Pearl 22 Harbor Survivor, "Combat-wounded veteran, "or "U.S. Reserve" 23 24 shall be deposited into the Grants and Donations Trust Fund, 25 as described in s. 296.38(2), to be used for the purposes established by law for that trust fund. 26 27 (c) Notwithstanding any provisions of law to the 28 contrary, an applicant for a Pearl Harbor Survivor license 29 plate or a Purple Heart license plate who also qualifies for a disabled veteran's license plate under s. 320.084 shall be 30

issued the appropriate special license plate without payment
of the license tax imposed by s. 320.08.

3 FORMER PRISONERS OF WAR.--Each owner or lessee of (2) an automobile or truck for private use, truck weighing not 4 5 more than 7,999 pounds, or recreational vehicle as specified б in s. 320.08(9)(c) or (d), which is not used for hire or 7 commercial use, who is a resident of the state and who is a former prisoner of war, or their unremarried surviving spouse, 8 9 shall, upon application therefor to the department, be issued 10 a license plate as provided in s. 320.06, on which license 11 plate are stamped the words "Ex-POW" followed by the serial number. Each application shall be accompanied by proof that 12 13 the applicant meets the qualifications specified in paragraph 14 (a) or paragraph (b).

(a) A citizen of the United States who served as a 15 member of the Armed Forces of the United States or the armed 16 17 forces of a nation allied with the United States who was held as a prisoner of war at such time as the Armed Forces of the 18 19 United States were engaged in combat, or their unremarried surviving spouse, may be issued the special license plate 20 provided for in this subsection without payment of the license 21 22 tax imposed by s. 320.08.

(b) A person who was serving as a civilian with the 23 24 consent of the United States Government, or a person who was a member of the Armed Forces of the United States who was not a 25 United States citizen and was held as a prisoner of war when 26 the Armed Forces of the United States were engaged in combat, 27 28 or their unremarried surviving spouse, may be issued the 29 special license plate provided for in this subsection upon payment of the license tax imposed by s. 320.08. 30 31

1 (3) PURPLE HEART MEDAL RECIPIENTS SURVIVING 2 SPOUSES. -- Each owner or lessee of an automobile or truck for 3 private use, truck weighing not more than 7,999 pounds, or recreational vehicle as specified in s. 320.08(9)(c) or (d), 4 5 which is not used for hire or commercial use, who is a б resident of this state and who is the unremarried surviving 7 spouse of a recipient of the Purple Heart medal shall, upon 8 application therefor to the department, with the payment of 9 the required fees, be issued a license plate as provided in s. 10 320.06, on which license plate are stamped the words "Purple 11 Heart" and the likeness of the Purple Heart medal followed by the serial number. Each application shall be accompanied by 12 13 proof that the applicant is the unremarried surviving spouse of a recipient of the Purple Heart medal. 14 (4) FIREFIGHTERS.--Each owner or lessee of an 15 automobile or truck for private use or recreational vehicle as 16 17 specified in s. 320.08(9)(c) or (d), which is not used for hire or commercial use, who is a resident of the state and an 18 19 active or retired firefighter, the spouse of such firefighter, 20 or the unremarried surviving spouse of a firefighter shall, upon application to the department and upon payment of the 21 22 applicable license taxes and use fees, be issued a license plate as provided by s. 320.06. Each application shall be 23 24 accompanied by proof that the applicant is an active or 25 retired firefighter, the spouse of such firefighter, or the unremarried surviving spouse of a firefighter, including, but 26 not limited to, a current identification and badge or a letter 27 28 from the firefighters' association of which the firefighter is 29 or was a member. 30 (a) Notwithstanding any other provision of law, the 31 department shall develop a Firefighter license plate as

provided in this subsection. Firefighter license plates must bear the colors and design approved by the department. The word "Florida" must appear at the top of the plate and the word "Firefighter" must appear at the bottom of the plate. The proceeds of the annual use fee shall be (b) б distributed equally to Shands Burn Center at the University of Florida in Alachua County, Orlando Regional Medical Center Burn Unit in Orange County, University of Miami-Jackson Memorial Burn Center in Miami-Dade County, and Tampa General Hospital Regional Burn Center in Hillsborough County. The funds shall be used specifically for the burn center or unit at each of those health care facilities. Section 3. This act shall take effect July 1, 2003.
