25	<u>and is properly equipped with a container used for</u>		
26	<u>transporting and dumping various materials, resources, or</u>		
27	<u>items.</u>		
28	<u>(b) "Person" means any form of corporation, limited</u>		
29	<u>liability company, partnership, association, cooperative,</u>		
30	<u>joint venture, business trust, sole proprietorship, or</u>		
31	<u>self-employed person who conducts business in this state.</u>

1 (2) Any person engaged in retrofitting, rebuilding, or
 2 modifying commercial trucks, truck tractors, or heavy trucks,
 3 as defined in s. 320.01, into dump trucks must have evidence
 4 that he or she is insured under a garage liability insurance
 5 policy that includes, at a minimum, \$1 million combined
 6 single-limit liability coverage, including bodily injury and
 7 property damage protection. Evidence of such insurance policy
 8 must be available at all reasonable hours for inspection by
 9 any law enforcement officer.

10 (3) Any person engaged in retrofitting, rebuilding, or
 11 modifying commercial trucks, truck tractors, or heavy trucks,
 12 as defined in s. 320.01, into dump trucks must ensure that
 13 such retrofitted, rebuilt, or modified dump trucks comply with
 14 all federal safety standards provided in 49 C.F.R. s. 393.

15 (4) Any person who violates subsection (2) or
 16 subsection (3) commits a misdemeanor of the second degree,
 17 punishable as provided in s. 775.082 or s. 775.083. Any person
 18 who violates subsection (2) or subsection (3) a second time
 19 commits a misdemeanor of the first degree, punishable as
 20 provided in s. 775.082 or s. 775.083. Any person who violates
 21 subsection (2) or subsection (3) a third or subsequent time
 22 commits a felony of the third degree, punishable as provided
 23 in s. 775.082, s. 775.083, or s. 775.084.
