STATEMENT OF SUBSTANTIAL CHANGES CONTAINED IN COMMITTEE SUBSTITUTE FOR Senate Bill 272

Requires at least ten emergency drills per school year, at least five of which must be emergency egress drills, at least one of which must be an accidental or intentional hazardous material release drill, and at least two of which must be tornado drills. The focus of two emergency drills shall be at the discretion of each school.
