Subsection (39) is added to section 320.08058, Florida Statutes, to read: 20 21 320.08058 Specialty license plates .--(39) CHILD ABUSE PREVENTION AND INTERVENTION LICENSE 22 23 PLATES.--24 (a) The department shall develop a Child Abuse Prevention and Intervention license plate as provided in this 25 26 section. The word "Florida" must appear at the top of the plate, and the words "Stop Child Abuse" must appear at the 27 28 bottom of the plate. 29 The annual use fees shall be distributed to the (b) Children's Home Society of Florida and the Florida Network of 30 Children's Advocacy Centers as follows: The first \$90,000 in 31

annual use fees shall be equally divided between the two 1 2 organizations, to be used to pay start-up costs, including costs incurred in developing and issuing the plates. 3 Thereafter, 50 percent of the proceeds shall be distributed to 4 5 the Children's Home Society of Florida, which must distribute the funds proportionately to each of its divisions, to be used б 7 for child abuse prevention programs. The other 50 percent of 8 the proceeds shall be distributed to the board of directors 9 of the Florida Network of Children's Advocacy Centers, Inc., who shall develop funding criteria and an allocation 10 methodology that ensures an equitable distribution of those 11 12 funds among network participant centers that meet the standards set forth in s. 39.3035. The criteria and 13 14 methodologies shall take into account factors that include, but need not be limited to, the center's accreditation status 15 16 with respect to the National Children's Alliance, the number 17 of clients served, and the population of the area being served by the children's advocacy center. 18 19 (c) For the first 5 years in which the plate is 20 issued, a maximum of 20 percent of the fees collected may be used for administrative costs directly associated with the 21 operation of the marketing and promotion of the plate. Ten 22 23 percent of the fees shall be allocated to the Children's Home Society of Florida and 10 percent shall be allocated to the 24 Florida Network of Children's Advocacy Centers, Inc. Five 25 26 years after the date the first license plate is issued, 27 revenues from plate sales may not be used for marketing or promoting the license plate. 28 29 Section 3.
