SUMMARY ANALYSIS

In an effort to ensure the safety of Florida's food supply in the aftermath of 9-11 and the Mad Cow disease outbreak in Europe, the Commissioner of Agriculture established a Food Safety Task Force. The Task Force is composed of representatives from every facet of the food industry: production, processing, distribution, sales, consumers, food industry groups, experts in food safety, agencies charged with food safety responsibilities, and legislative representatives. The purpose of the Task Force is to provide a forum for presenting, investigating, and evaluating issues of current importance in food safety.

HB 339 transforms this "ad-hoc" task force into a permanent advisory council (Florida Food Safety and Food Security Advisory Council) under the Department of Agriculture and Consumer Services (department). All members of the Council, with the exception of the Secretaries of the Department of Health and the Department of Business and Professional Regulation and the legislative representatives, are appointed by the Commissioner of Agriculture. The Council will periodically report findings and recommendations to the department. In performing its duties, the Council members may receive confidential data exempt from the provisions of s. 119.07(1), F.S., for review; it is unlawful for any member of the Council to use the data for his/her advantage or reveal the data to the general public.

Appropriations of \$5,000 are provided from the department's Contracts and Grants Trust Fund and from the General Inspection Trust Fund. These funds are for the payment of costs associated with conducting the business of the Council.

*The revenue estimates are based on anticipated grant money (Contracts and Grants Trust Fund) from the United States Food and Drug Administration for the purpose of encouraging states to establish such advisory bodies. Sufficient revenues exist in the General Inspection Trust Fund to cover the state's portion of the costs associated with conducting activities of the Council.

This bill turns an "ad-hoc" task force that has been in existence since 9-11 into a task force with permanent standing. As such, administrative costs to support the Florida Food Safety and Food Security Advisory Council and travel and per diem costs for council members, projected to be \$10,000 or less, would be incurred by the department.

IV. AMENDMENTS/COMMITTEE SUBSTITUTE CHANGES

On March 6, 2003, the Committee on Agriculture unanimously adopted a strike-all amendment to HB 339. This analysis reflects the contents of that amendment.

On April 11, 2003, the Subcommittee on Agriculture and Environment Appropriations adopted two amendments:

- a. Adds a representative from the Department of Law Enforcement to the Advisory Council,
- b. Provides for a nonrecurring annual appropriation of \$10,000 in trust fund authority for covering the costs of the council.

On April 21, 2003, the Committee on Appropriations adopted both subcommittee amendments.
