WHEREAS, HIV/AIDS is one of the state's most critical public health challenges, with Florida having the third highest number of AIDS cases in the nation and the second highest number of pediatric AIDS cases, and

WHEREAS, minorities, primarily blacks and Hispanics, now constitute 61 percent of the more than 83,000 adult and pediatric AIDS cases reported in Florida since the epidemic began in 1981, and

WHEREAS, the HIV/AIDS epidemic has disproportionately affected Florida's minority communities, and

WHEREAS, the total medical and related lifetime costs for a patient infected with HIV may reach \$175,000 or more, and

WHEREAS, the Legislature finds that sustained, comprehensive prevention efforts can have a substantial impact on slowing the course of the HIV/AIDS epidemic, and

WHEREAS, the Legislature intends to decrease the number of deaths of minorities due to HIV/AIDS by increasing public awareness, increasing early detection and treatment of HIV/AIDS in the state's minority communities, and increasing the coordination of HIV/AIDS prevention and treatment efforts in the state's minority communities, and

WHEREAS, the prevalence of HIV/AIDS in the state's county jails and state prisons exceeds the prevalence of HIV/AIDS in the general population, and

WHEREAS, recent advances in treatment for HIV/AIDS can potentially reduce the number of opportunistic infections and associated medical costs and delay the onset of death due to the disease, and

WHEREAS, referral to appropriate medical and social services upon the release of an inmate can play a crucial role in treatment, care, and secondary prevention efforts, and

WHEREAS, the Legislature authorized the creation of the Minority HIV and AIDS Task Force to provide recommendations on strategies to strengthen HIV/AIDS prevention, early intervention, and treatment efforts in Florida's minority communities, NOW, THEREFORE,

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 381.0046, Florida Statutes, is amended to read:

381.0046 Statewide HIV and AIDS prevention campaign. --

(1) The Department of Health shall develop and implement a statewide HIV and AIDS prevention campaign that is directed towards minorities who are at risk of HIV infection. The campaign shall include television, radio, and outdoor

advertising; public service announcements; and peer-to-peer

outreach. Each campaign message and concept shall be evaluated with members of the target group to ensure its effectiveness.

The campaign shall provide information on the risk of HIV and AIDS infection and strategies to follow for prevention, early

detection, and treatment. The campaign shall use culturally

sensitive literature and educational materials and promote the development of individual skills for behavior modification. The

campaign shall be expanded to include prevention information specifically targeted to Florida's Hispanic and Haitian

(2) The Department of Health shall establish eight four positions within the department for HIV and AIDS regional minority coordinators and one position for a statewide HIV and AIDS minority coordinator. The coordinators shall facilitate

shall report directly to the chief of the Bureau of HIV and AIDS within the Department of Health.

- outreach programs in Florida's minority communities to identify persons infected with HIV/AIDS. These programs shall address real and perceived barriers to HIV testing among Florida's minority populations. The Department of Health shall, with assistance from the Minority HIV and AIDS Task Force and the statewide coordinator, plan and conduct a statewide Black Leadership Conference on HIV and AIDS by January 2000. The conference shall provide workshops for minority organizations in building skills and improving an organization's capacity to conduct HIV and AIDS prevention and treatment programs.
- (4) The department shall provide a program to ensure that HIV-positive persons are linked with prevention, care, and support services. This program shall be provided in a culturally sensitive manner to promote prevention among persons who are HIV positive and increase the acceptance and delivery of care and support services in high-risk communities.
- (5) The department shall expand testing programs for HIV, sexually transmissible diseases, and hepatitis in local county jails. The department shall establish programs for HIV-positive county jail and state prison inmates to ensure coordination and linkage to treatment and secondary prevention messages upon their release.
- (6) To promote HIV testing among minority persons who are at risk of infection, the department shall expand its HIV

110 counseling, testing, and referral services to include additional
111 Orasure testing.

- (7) These minority programs shall be consistent with the findings and recommendations of the Minority HIV and AIDS Task Force, the HIV/AIDS Comprehensive Prevention Plan, and the recommendations of the Centers for Disease Control and Prevention.
 - Section 2. This act shall take effect upon becoming a law.
