Section 6. Section 257.261, Florida Statutes, is amended to read:

257.261 Library registration and circulation records.--

(1) All registration and circulation records of every public library, except statistical reports of registration and circulation, are confidential and exempt from the provisions of s. 119.07(1) and from s. 24(a) of Art. I of the State Constitution. ~~Except in accordance with proper judicial order, a person may not make known in any manner any information contained in such records, except as provided in this section.~~

(2) As used in this section, the term "registration records" includes any information that a library requires a patron to provide in order to become eligible to borrow books

28 and other materials, and the term "circulation records" includes
29 all information that identifies the patrons who borrow
30 particular books and other materials.

31 (3)(a) Except in accordance with a proper judicial order,
32 a person may not make known in any manner any information
33 contained in records made confidential and exempt by this
34 section, except as otherwise provided in this section.

35 (b) A This section does not prohibit any library, or any
36 business operating jointly with the library may, only for the
37 purpose of collecting fines or recovering overdue books,
38 documents, films, or other items or materials owned or otherwise
39 belonging to the library, disclose, from disclosing information
40 made confidential and exempt by this section to the following:

41 1. The library patron named in the records;

42 2. In the case of a library patron less than 16 years of
43 age, the parent or guardian of that patron named in the records;

44 3. Any entity that collects fines on behalf of a library,
45 unless the patron is less than 16 years of age, in which case
46 only information identifying the patron's parent or guardian may
47 be released;

48 4. Municipal or county law enforcement officials, unless
49 the patron is 16 years of age, in which case only information
50 identifying the patron's parent or guardian may be released; or

52 5. Judicial officials., for the purpose of recovering
53 overdue books, documents, films, or other items or materials
54 owned or otherwise belonging to the library. This section does
55 not prohibit any library, or any business operating jointly with
