61	Be It Enacted by the Legislature of the State of Florida:

63	Section 1. The facts stated in the preamble to this act
64	are found and declared to be true.
65	Section 2. The Board of County Commissioners of St. Lucie
66	County is authorized and directed to appropriate from funds of
67	the county not otherwise appropriated and to draw a warrant in
68	the sum of \$50,000 payable to Richard Ebner and Denise Ebner to
69	compensate them for injuries sustained due to the negligence of
70	St. Lucie County. The funds designated for their benefit shall
71	be used to pay statutory fees, costs, outstanding medical liens,
72	and other immediate needs of the claimants.
73	Section 3. This act shall take effect upon becoming a law.
