A bill to be entitled

An act relating to the Northwest Florida Water Management District; amending s. 373.4145, F.S.; continuing the interim part IV permitting program for the Northwest Florida Water Management District; providing a future repeal of such interim program; removing obsolete provisions; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Notwithstanding the repeal of subsections (1), (2), (3), and (4) of section 373.4145, Florida Statutes, scheduled for July 1, 2003, said subsections are reenacted, and subsections (6) and (7) of said section are amended, to read:

373.4145 Interim part IV permitting program for the Northwest Florida Water Management District.--

(1) Within the geographical jurisdiction of the Northwest Florida Water Management District, the permitting authority of the department under this part shall consist solely of the following, notwithstanding the rule adoption deadline in s. 373.414(9):

(a) Chapter 17-25, Florida Administrative Code, shall remain in full force and effect, and shall be implemented by the department. Notwithstanding the provisions of this section, chapter 17-25, Florida Administrative Code, may be amended by the department as necessary to comply with any requirements of state or federal laws or regulations, or any condition imposed



29 | by a federal program, or as a requirement for receipt of federal
30 | grant funds.

31 | (b) Rules adopted pursuant to the authority of ss. 403.91-
32 | 403.929, 1984 Supplement to the Florida Statutes 1983, as
33 | amended, in effect prior to July 1, 1994, shall remain in full
34 | force and effect, and shall be implemented by the department.
35 | However, the department is authorized to establish additional
36 | exemptions and general permits for dredging and filling, if such
37 | exemptions or general permits do not allow significant adverse
38 | impacts to occur individually or cumulatively. However, for the
39 | purpose of chapter 17-312, Florida Administrative Code, the
40 | landward extent of surface waters of the state identified in
41 | rule 17-312.030(2), Florida Administrative Code, shall be
42 | determined in accordance with the methodology in rules 17-
43 | 340.100 through 17-340.600, Florida Administrative Code, as
44 | ratified in s. 373.4211, upon the effective date of such
45 | ratified methodology. In implementing s. 373.421(2), the
46 | department shall determine the extent of those surface waters
47 | and wetlands within the regulatory authority of the department
48 | as described in this paragraph. At the request of the
49 | petitioner, the department shall also determine the extent of
50 | surface waters and wetlands which can be delineated by the
51 | methodology ratified in s. 373.4211, but which are not subject
52 | to the regulatory authority of the department as described in
53 | this paragraph.

54 | (c) The department may implement chapter 40A-4, Florida
55 | Administrative Code, in effect prior to July 1, 1994, pursuant



56 to an interagency agreement with the Northwest Florida Water
57 Management District adopted under s. 373.046(4).

58 (2) The authority of the Northwest Florida Water
59 Management District to implement this part or to implement any
60 authority pursuant to delegation by the department shall not be
61 affected by this section. The rule adoption deadline in s.
62 373.414(9) shall not apply to said district.

63 (3) The division of permitting responsibilities in s.
64 373.046(4) shall not apply within the geographical jurisdiction
65 of the Northwest Florida Water Management District.

66 (4) If the United States Environmental Protection Agency
67 approves an assumption of the federal program to regulate the
68 discharge of dredged or fill material by the department or the
69 water management districts, or both, pursuant to s. 404 of the
70 Clean Water Act, Pub. L. No. 92-500, as amended, 33 U.S.C. ss.
71 1251 et seq.; the United States Army Corps of Engineers issues
72 one or more state programmatic general permits under the
73 referenced statutes; or the United States Environmental
74 Protection Agency or the United States Corps of Engineers
75 approves any other delegation of regulatory authority under the
76 referenced statutes, then the department may implement any
77 permitting authority granted in this part within the Northwest
78 Florida Water Management District which is prescribed as a
79 condition of granting such assumption, general permit, or
80 delegation.

81 (6) Subsections (1), (2), (3), and (4) shall be repealed
82 effective July 1, 2005 ~~2003~~.



83 ~~(7)(a) The department and the Northwest Florida Water~~
84 ~~Management District are directed to begin developing a plan by~~
85 ~~which the permitting for activities proposed in surface waters~~
86 ~~and wetlands shall fully comply with the provisions of this~~
87 ~~part, beginning July 1, 2003. The plan also shall address the~~
88 ~~division of environmental resource permitting responsibilities~~
89 ~~between the department and the Northwest Florida Water~~
90 ~~Management District; the methodology of delineating wetlands in~~
91 ~~the Northwest Florida Water Management District; authority of~~
92 ~~the Northwest Florida Water Management District to implement~~

101 ~~Speaker of the House of Representatives, and the chairs of the~~
102 ~~relevant substantive and fiscal committees. The department and~~
103 ~~district shall present a final report on March 1, 2003.~~

104 ~~(c) Any jurisdictional declaratory statement issued for a~~
105 ~~project within the geographic jurisdiction of the Northwest~~
106 ~~Florida Water Management District that is valid on July 1, 1999,~~
107 ~~and for which there has been issued a permit pursuant to this~~
108 ~~chapter and chapter 403 for a phase of that project and which~~
109 ~~identified proposed future development, including mitigation,~~
