An act relating to the Central Florida Regional Transportation Authority; amending s. 343.63, F.S.; revising membership of the governing board of the authority; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Subsections (2) and (3) of section 343.63, Florida Statutes, are amended to read:

343.63 Central Florida Regional Transportation Authority.--

(2) The governing board of the authority shall consist of five ~~11~~ voting members, ~~and 1 nonvoting member~~ as follows:

(a) The chairs of the county commissions of Seminole, Orange, and Osceola Counties, or another member of the commission designated by the county chair, shall each serve as a ~~elect a commissioner as that commission's~~ representative on the
