A bill to be entitled

An act relating to trust funds; creating s. 260.22, F.S.; creating the Florida National Scenic Trail Trust Fund within the Department of Environmental Protection; providing for source of moneys and purposes; providing for a public-private partnership; providing for annual carryforward of unused funds; providing for future review and termination or re-creation of the trust fund; amending s. 259.1051, F.S.; transferring certain funds from the Florida Forever Trust Fund to the Florida National Scenic Trail Trust Fund; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 260.22, Florida Statutes, is created to read:

260.22 Florida National Scenic Trail Trust Fund.--

(1) There is created the Florida National Scenic Trail

Trust Fund within the Department of Environmental Protection.

The trust fund shall consist of funds transferred to the trust fund as provided in s. 259.1051(4) and funds contributed from any other source.

(2)(a) Funds shall be used to purchase sufficient legal interest in the private property corridor needed to complete and maintain the Florida National Scenic Trail.

(b) Funds from the initial transfer under s. 259.1051(4) shall be used as a basis for the Florida Green Ribbon Campaign, a public-private partnership between the department and interested greenways, trails, and waterways organizations, the purpose of which is to solicit sufficient moneys from federal

and local governments, corporations and other business entities, private citizens, and any other source to complete the Florida

National Scenic Trail by 2010.

- (3) Notwithstanding the provisions of s. 216.301 and pursuant to s. 216.351, any balance in the trust fund at the end of any fiscal year shall remain in the trust fund at the end of the year and shall be available for carrying out the purposes of the trust fund.
- (4) Pursuant to the provisions of s. 19(f)(2), Art. III of the State Constitution, the trust fund shall, unless terminated sooner, be terminated on July 1, 2007. Prior to its scheduled termination, the trust fund shall be reviewed as provided in s. 215.3206.
- Section 2. Subsection (4) is added to section 259.1051, Florida Statutes, to read:
 - 259.1051 Florida Forever Trust Fund. --
- (4) For the 2003-2004 fiscal year only, and notwithstanding any other provision of this section and s.

 259.105(3) to the contrary, the sum of \$20 million shall be transferred from the Florida Forever Trust Fund to the Florida

 National Scenic Trail Trust Fund to be used for the purposes specified in s. 260.22. Such transfer shall occur not later than September 30, 2003, and prior to the transfer of proceeds pursuant to s. 259.105(3). This subsection expires July 1, 2004.

 Section 3. This act shall take effect July 1, 2003.
