Paragraph (j) is added to subsection (2) of 17 section 471.003, Florida Statutes, to read: 471.003 Qualifications for practice; exemptions.--18 19 (2) The following persons are not required to be 20 licensed under the provisions of this chapter as a licensed 21 engineer: 22 (j) Any defense, space, or aerospace company, whether a sole proprietorship, firm, limited liability company, 23 partnership, joint venture, joint stock association, 24 25 corporation, or other business entity, subsidiary, or 26 affiliate, or any employee, contract worker, subcontractor, or 27 independent contractor of the defense, space, or aerospace 2.8 company who provides engineering for aircraft, space launch 29 vehicles, launch services, satellites, satellite services, or 30 other defense, space, or aerospace-related product or services, or components thereof. 31 1

Subsections (12) and (13) are added to section 471.005, Florida Statutes, to read: 2 3 471.005 Definitions.--As used in this chapter, the 4 term: 5 "Space or aerospace company" means any business (12) б entity concerned with the design, manufacture, or support of 7 aircraft, rockets, missiles, spacecraft, satellites, space 8 vehicles, space stations, space facilities, or components thereof, and equipment, systems, facilities, simulators, 9 10 programs, products, services, and activities related thereto. 11 (13) "Defense company" means any business entity that holds a valid Department of Defense contract or any business 12 entity that is a subcontractor under a valid Department of 13 Defense contract. The term includes any business entity that 14 holds valid contracts or subcontracts for products or services 15 for military use under prime contracts with the United States 16 17 Department of Defense, the United States Department of State, or the United States Coast Guard. 18 19 Section 3. Subsection (1) of section 471.031, Florida Statutes, is amended to read: 20 21 471.031 Prohibitions; penalties.--22 (1) A person may not: (a) Practice engineering unless the person is licensed 23 or exempt from licensure under this chapter.+ 24 25 (b)1. Except as provided in subparagraph 2., use the name or title "professional engineer" or any other title, 26 27 designation, words, letters, abbreviations, or device tending 28 to indicate that such person holds an active license as an 29 engineer when the person is not licensed under this chapter, including, but not limited to, the following titles: 30 31 "agricultural engineer," "air-conditioning engineer,"

This act shall take effect upon becoming a 29 law. 30 31
