 4           the Florida Statutes 2004 and designating the portions

 6           state; providing that the Florida Statutes 2004 shall be  
 7           effective immediately upon publication; providing that  
 8           general laws enacted during the August 12-13, 2003,  
 9           Special Session and prior thereto and not included in the  
 10          Florida Statutes 2004 are repealed; providing that general  
 11          laws enacted during the October 20-24, 2003, Special  
 12          Session and the 2004 regular session are not repealed by  
 13          this adoption act; providing an effective date.

 15   Be It Enacted by the Legislature of the State of Florida:

 17          Section 1. Section 11.2421, Florida Statutes, is amended  
 18          to read:

19          11.2421 Florida Statutes 2004 ~~2003~~ adopted.--The  
 20          accompanying revision, consolidation, and compilation of the  
 21          public statutes of 2003 ~~2002~~ of a general and permanent nature,  
 22          excepting tables, rules, indexes, and other related matter  
 23          contained therein, prepared by the Office of Legislative  
 24          Services under the provisions of s. 11.242, together with  
 25          corrections, changes, and amendments to and repeals of  
 26          provisions of Florida Statutes 2003 ~~2002~~ enacted in additional  
 27          reviser's bill or bills by the 2004 ~~2003~~ Legislature, is adopted  
 28          and enacted as the official statute law of the state under the  
 29          title of "Florida Statutes 2004 ~~2003~~" and shall take effect

 34 to read:

35 11.2422 Statutes repealed.--Every statute of a general and  
 36 permanent nature enacted by the State or by the Territory of  
 37 Florida at or prior to the August 12-13, 2003 ~~April 29-May 13,~~  
 38 ~~2002~~, special legislative session, and every part of such  
 39 statute, not included in Florida Statutes 2004 ~~2003~~, as adopted  
 40 by s. 11.2421, as amended, or recognized and continued in force  
 41 by reference therein or in ss. 11.2423 and 11.2424, as amended,  
 42 is repealed.

43 Section 3. Section 11.2424, Florida Statutes, is amended  
 44 to read:

45 11.2424 Laws not repealed.--Laws enacted at the October  
 46 20-24, 2003, Special Session and the 2004 ~~2003~~ regular session  
 47 are not repealed by the adoption and enactment of the Florida  
 48 Statutes 2004 ~~2003~~ by s. 11.2421, as amended, but shall have  
 49 full effect as if enacted after its said adoption and enactment.

50 Section 4. Section 11.2425, Florida Statutes, is amended  
 51 to read:

52 11.2425 Rights reserved under repealed statutes.--The  
 53 repeal of any statute by the adoption and enactment of Florida  
 54 Statutes 2004 ~~2003~~, by s. 11.2421, as amended, shall not affect  
 55 any right accrued before such repeal or any civil remedy where a  
 56 suit is pending.
