Robinson High School in Tampa, Florida, 11 12 who led the student body not only as the Student Government President, but by example of character and citizenship as 13 well; and who was a cheerleader, wrestler, active in the 14 National Junior ROTC program, a National Honor Society member, 15 a Tampa Tribune Scholar, graduated third in his class, and had 16 17 been awarded a full scholarship to Florida State University, 18 and 19 WHEREAS, Andrew delayed his college education to answer 20 the call of duty and serve as a Lance Corporal in the U.S. 21 Marine Corps Reserve as a member of the 4th Assault Amphibian 22 Battalion based in Tampa, and 23 WHEREAS, Lance Corporal Aviles was killed in the line of duty in Iraq on April 7, 2003, while securing a bridge 24 25 during Operation Iraqi Freedom, and 26 WHEREAS, Lance Corporal Aviles was laid to rest on June 19, 2003, at Arlington National Cemetery with full military 27 honors, and 28 29 WHEREAS, Lance Corporal Aviles was posthumously 30 decorated with a Purple Heart and the Navy and Marine Corps

Achievement Medal for Superior Performance in the Line of 2 Duty, and 3 WHEREAS, Lance Corporal Aviles will forever be 4 remembered as a role model and inspiration to all for his 5 outstanding achievements during his short life; his love and 6 devotion to his family, friends, and his country; and for the 7 ultimate sacrifice he made, NOW, THEREFORE, 8 9 Be It Enacted by the Legislature of the State of Florida: 10 11 Section 1. Andrew J.
