19 designating the new Allied Health Building at
20 Florida Agricultural and Mechanical University
21 as the "Margaret W. Lewis/Jacqueline B. Beck
22 Allied Health Building"; designating the
23 Architecture Building at Florida Agricultural
24 and Mechanical University as the "Walter L.
25 Smith Architecture Building"; designating the
26 Archives Building at Florida Agricultural and
27 Mechanical University as the "Carrie Meek/James
28 N. Eaton, Sr. Southeastern Regional Black
29 Archives Research Center and Museum;
30 authorizing Florida Agricultural and Mechanical
31 University to erect suitable markers;

1 designating the new Structures and Materials
2 Research Laboratory for the College of
3 Engineering at the University of Florida as
4 "The Powell Family Structures and Materials
5 Laboratory"; designating the track/soccer
6 stadium at the University of Florida as the
7 "James G. Pressly Track/Soccer Stadium";
8 designating the Academic Advising Center at the
9 University of Florida as "Farrrior Hall";
10 designating the proposed band rehearsal
11 facility at the University of Florida as
12 "Steinbrenner Band Hall"; redesignating
13 North-South Drive on the University of Florida
14 campus as "Gale Lemerand Drive"; directing the
15 University of Florida to erect markers;
16 providing an effective date.

18 Be It Enacted by the Legislature of the State of Florida:

19

20 Section 1. Kleist Health Education Center designated;
21 Florida Gulf Coast University to erect suitable markers.--

22 (1) The student community educational facility for
23 health at Florida Gulf Coast University is designated as
24 "Kleist Health Education Center."

25 (2) Florida Gulf Coast University is authorized to
26 erect suitable markers designating Kleist Health Education
27 Center as described in subsection (1).

28 Section 2. Herbert J. and Margaret S. Sugden Hall
29 designated; Florida Gulf Coast University to erect suitable
30 markers.--

31

1 (1) The facility at Florida Gulf Coast University
2 which will house the resort and hospitality management program
3 is designated as "Herbert J. and Margaret S. Sugden Hall."

4 (2) Florida Gulf Coast University is authorized to
5 erect suitable markers designating Herbert J. and Margaret S.
6 Sugden Hall as described in subsection (1).

7 Section 3. James and Annie Ying Academic Center
8 designated; University of Central Florida to erect suitable
9 markers.--

10 (1) The building that houses the University of Central
11 Florida Downtown Center is designated as the "James and Annie
12 Ying Academic Center."

13 (2) The University of Central Florida is authorized to
14 erect suitable markers designating the James and Annie Ying
15 Academic Center as described in subsection (1).

16 Section 4. Sybil C. Mobley Business Building
17 designated; Florida Agricultural and Mechanical University to
18 erect suitable markers.--

19 (1) The School of Business and Industry Building at
20 Florida Agricultural and Mechanical University is designated
21 as the "Sybil C. Mobley Business Building."

22 (2) Florida Agricultural and Mechanical University is
23 authorized to erect suitable markers designating the Sybil C.
24 Mobley Business Building as described in subsection (1).

25 Section 5. Margaret W. Lewis/Jacqueline B. Beck Allied
26 Health Building designated; Florida Agricultural and
27 Mechanical University to erect suitable markers.--

28 (1) The new Allied Health Building at Florida
29 Agricultural and Mechanical University is designated as the
30 "Margaret W. Lewis/Jacqueline B. Beck Allied Health Building."

31

1 (2) Florida Agricultural and Mechanical University is
2 authorized to erect suitable markers designating the Margaret
3 W. Lewis/Jacqueline B. Beck Allied Health Building as
4 described in subsection (1).

5 Section 6. Walter L. Smith Architecture Building
6 designated; Florida Agricultural and Mechanical University to
7 erect suitable markers.--

8 (1) The Architecture Building at Florida Agricultural
9 and Mechanical University is designated as the "Walter L.
10 Smith Architecture Building."

11 (2) Florida Agricultural and Mechanical University is
12 authorized to erect suitable markers designating the Walter L.
13 Smith Architecture Building as described in subsection (1).

14 Section 7. Carrie Meek/James N. Eaton, Sr.
15 Southeastern Regional Black Archives Research Center and
16 Museum designated; Florida Agricultural and Mechanical
17 University to erect suitable markers.--

18 (1) The Archives Building at Florida Agricultural and
19 Mechanical University is designated as the "Carrie Meek/James
20 N. Eaton, Sr. Southeastern Regional Black Archives Research
21 center and Museum."

22 (2) Florida Agricultural and Mechanical University is
23 authorized to erect suitable markers designating the Carrie
24 Meek/James N. Eaton, Sr. Southeastern Regional Black Archives
25 Research Center and Museum.

26 Section 8. Powell Family Structures and Materials
27 Laboratory designated; University of Florida to erect suitable
28 markers.--

29 (1) The new Structures and Materials Research
30 Laboratory for the College of Engineering at the University of
31

1 Florida is designated as "The Powell Family Structures and
2 Materials Laboratory."

3 (2) The University of Florida is directed to erect
4 suitable markers designating the Powell Family Structures and
5 Materials Laboratory as described in subsection (1).

6 Section 9. James G. Pressly Track/Soccer Stadium
7 designated; University of Florida to erect suitable markers.--

8 (1) The track/soccer stadium at the University of
9 Florida is designated as the "James G. Pressly Track/Soccer
10 Stadium."

11 (2) The University of Florida is directed to erect
12 suitable markers designating the James G. Pressly Track/Soccer
13 Stadium as described in subsection(1).

14 Section 10. Farrior Hall designated; University of
15 Florida to erect suitable markers.--

16 (1) The Academic Advising Center at the University of
17 Florida is designated as "Farrior Hall."

18 (2) The University of Florida is directed to erect
19 suitable markers designating Farrior Hall as described in
20 subsection (1).

21 Section 11. Steinbrenner Band Hall designated;
22 University of Florida to erect suitable markers.--

23 (1) The proposed band rehearsal facility at the
24 University of Florida is designated as "Steinbrenner Band
25 Hall."

26 (2) The University of Florida is directed to erect
27 suitable markers designating the Steinbrenner Band Hall as
28 described in subsection (1).

29 Section 12. Gale Lemerand Drive designated; University
30 of Florida to erect suitable markers.--

31

1 (1) The North-South Drive on the University of Florida
2 campus is redesignated as "Gale Lemerand Drive."

3 (2) The University of Florida is directed to erect
4 suitable markers designating Gale Lemerand Drive as described
5 in subsection (1).

6 Section 13. This act shall take effect July 1, 2004.

10 Senate Bill 1176

11 Designates the building that houses the University of Central
12 Florida Downtown Center as the "James and Annie Ying Academic
Center."

13 Designates the School of Business and Industry building at
14 Florida Agricultural and Mechanical University as the "Sybil
C. Mobley Business Building."

15 Designates the new Allied Health Building at Florida
16 Agricultural and Mechanical University as the "Margaret W.
Lewis/Jacqueline B. Beck Allied Health Building."

17 Designates the architecture building at Florida Agricultural
18 and Mechanical University as the "Walter L. Smith Architecture
Building."

19 Designates the Archives Building at Florida Agricultural and
20 Mechanical University as the "Carrie Meek/James N. Eaton, Sr.
Southeastern Regional Black Archives Research Center and
21 Museum."

22 Designates the new Structures and Materials Research
23 Laboratory for the College of Engineering at the University of
Florida as "The Powell Family Structures and Materials
Laboratory."

24 Designates the track/soccer stadium at the University of
25 Florida as the "James G. Pressly Track/Soccer Stadium."

26 Designates the Academic Advising Center at the University of
Florida as "Farrior Hall."

27 Designates the proposed band rehearsal facility at the
28 University of Florida as "Steinbrenner Band Hall."

29 Designates the North-South Drive on the University of Florida
campus as "Gale Lemerand Drive."
