### **SUMMARY ANALYSIS**

Section 334.071, F.S., specifies the purpose and effect of the designation of roads, bridges, and other transportation facilities for honorary or memorial purposes by the Florida Legislature.

HB 1263 designates a portion of State Road 111 on Edgewood Avenue West in Duval County from the intersection at U.S. Highway 1 east to Interstate 95 where Edgewood Avenue Becomes Tallulah Avenue as the "Robert 'Bullet Bob' Hayes Avenue."

The Florida Department of Transportation (FDOT) is directed to erect suitable markers to denote the honorary designations. The markers will cost approximately \$800.00.

HB 1263 does not create any constitutional issues. It takes effect upon becoming law.

### B. EFFECT OF PROPOSED CHANGES:

Section 334.071, F.S., provides for legislative designations of transportation facilities for honorary or memorial purposes, or to distinguish a particular facility. The legislative designations do not "officially" change the current names of the facilities, nor does it require local governments and private entities to change street signs, mailing addresses, or 911 emergency telephone-number system listings. The statute requires FDOT to place a marker at each terminus or intersection of an identified road or bridge, and to erect other markers it deems appropriate for the transportation facility. The statute also provides that a city or county must pass a resolution in support of a particular designation before road markers are erected. Additionally, if the designated road segment extends through multiple cities or counties then a resolution must be passed by each affected local government.

Based on FDOT records, 999 honorary road and bridge designations have been approved since 1922, most of them by the Legislature. Some public roads and bridges have multiple or overlapping designations.

HB 1263 creates one additional road designation. HB 1263 designates a portion of State Road 111 on Edgewood Avenue West in Duval County from the intersection at U.S. Highway 1 east to Interstate 95 where Edgewood Avenue Becomes Tallulah Avenue as the "Robert 'Bullet Bob' Hayes Avenue."

FDOT is directed to erect suitable makers for the designation.

Section 1: Creates an honorary designation in Duval County from State Road 111 on Edgewood Avenue West in Duval County from the intersection at U.S. Highway 1 east to Interstate 95 where Edgewood Avenue becomes Tallulah Avenue as the "Robert 'Bullet Bob' Hayes Avenue."
