as provided in section 775.082 or section 775.083, Florida Statutes, for a person to harass a member of a neighborhood crime watch program while such member is traveling to or from a neighborhood crime watch meeting, actively participating in a neighborhood crime watch meeting or activity, or actively participating in an ongoing criminal investigation, as designated by a law enforcement officer. (2) As used in this section, the term "harass" means to engage in a course of conduct directed at a specific person which causes substantial emotional distress in that person and serves no legitimate purpose.
