11.2422 Statutes repealed.--Every statute of a general and permanent nature enacted by the State or by the Territory of Florida at or prior to the August 12-13, 2003 April 29-May 13, 2002, special legislative session, and every part of such statute, not included in Florida Statutes 2004 2003, as adopted by s. 11.2421, as amended, or recognized and continued in force by reference therein or in ss. 11.2423 and 11.2424, as amended, is repealed.

Section 3. Section 11.2424, Florida Statutes, is amended to read:

11.2424 Laws not repealed.--Laws enacted at the October 20-24, 2003, Special Session and the 2004 2003 regular session are not repealed by the adoption and enactment of the Florida Statutes 2004 2003 by s. 11.2421, as amended, but shall have full effect as if enacted after its said adoption and enactment.

Section 4. Section 11.2425, Florida Statutes, is amended to read:

11.2425 Rights reserved under repealed statutes.--The repeal of any statute by the adoption and enactment of Florida Statutes 2004 2003, by s. 11.2421, as amended, shall not affect any right accrued before such repeal or any civil remedy where a suit is pending.
