### **SUMMARY ANALYSIS**

In order to practice barbering services for compensation, an individual must have a barber license or restricted barber license issued by the Department of Business and Professional Regulation (DBPR) and the Barbers' Board. A person holding a restricted barber's licenses is not permitted to provide services involving chemicals.

An individual can sit for the barber licensing examination after completing 1,000 school hours provided the individual meets other requirements for licensure. If the applicant fails to achieve a passing grade on either or both parts of the licensure examination, the applicant is required to complete an additional 200 school hours prior to retaking the examination. The applicant must complete a board approved HIV/AIDS course. There is currently no apprenticeship program to assist in the preparation for licensure as a barber.

In order to provide cosmetology services for compensation, an individual must have a cosmetology license issued by the DBPR and the Board of Cosmetology.

An applicant must complete 1,000 hours of approved formal education and training in order to sit for the cosmetology licensure examination provided the applicant meets other requirements for licensure. If the applicant fails the examination, the applicant is required to complete an additional 200 school hours. The applicant must also complete a board approved HIV/AIDS course for initial licensure. There is currently no apprenticeship program to assist in the preparation for licensure as a cosmetologist.

The bill establishes barbering and cosmetology apprenticeship programs and requires apprentices and sponsors to register with their respective boards. The bill authorizes the Barbers' Board and the Board of Cosmetology to adopt rules to establish standards and to administer and regulate the programs.

The bill requires the barber/cosmetology apprenticeship sponsor to be a licensed barber/cosmetologist or an association of employers who are licensed barbers/cosmetologists. The bill creates a registration fee cap of \$50 for barber/cosmetology apprentices and a registration fee cap of \$50 for barber/cosmetology sponsors.

The DBPR anticipates "the bill would result in an increase in board administrative activities, complaints, inspections, and investigations." The DBPR estimates "7,000 apprentices and 2,300 apprentice sponsors will require additional staffing and expenses to include 5.0 FTE positions and \$753,092 during the first two years of implementation."

The bill establishes barbering and cosmetology apprenticeship programs by registering apprentices and sponsors. The bill authorizes the Barbers' Board and the Board of Cosmetology to adopt rules to establish standards and to administer and regulate the programs.

The bill creates a registration fee cap of \$50 for barber/cosmetology apprentices and a registration fee cap of \$50 for barber/cosmetology sponsors

# B. EFFECT OF PROPOSED CHANGES:

#### Present Situation

In order to practice barbering services for compensation, an individual must have a barber license or restricted barber license issued by the Department of Business and Professional Regulation (DBPR) and the Barbers' Board. A person holding a restricted barber's licenses is not permitted to provide services involving chemicals.

An individual can sit for the barber licensing examination after completing 1,000 school hours provided the individual meets other requirements for licensure. If the applicant fails to achieve a passing grade on either or both parts of the licensure examination, the applicant is required to complete an additional 200 school hours prior to retaking the examination. The applicant must complete a board approved HIV/AIDS course. There is currently no apprenticeship program to assist in the preparation for licensure as a barber.

In order to provide cosmetology services for compensation, an individual must have a cosmetology license issued by the DBPR and the Board of Cosmetology.

An applicant must complete 1,000 hours of approved formal education and training in order to sit for the cosmetology licensure examination provided the applicant meets other requirements for licensure. If the applicant fails the examination, the applicant is required to complete an additional 200 school hours. The applicant must also complete a board approved HIV/AIDS course for initial licensure. There is currently no apprenticeship program to assist in the preparation for licensure as a cosmetologist.

### Effect of Proposed Changes

The bill requires barber/cosmetology apprentices and their sponsors to register with the DBPR. The bill requires the barber/cosmetology apprenticeship sponsor be a licensed barber/cosmetologist or an association of employers who are licensed barbers/cosmetologists. The sponsor may not sponsor more than three apprentices at once. The barber/cosmetologist is required to have held an active valid barber/cosmetology license for three consecutive years prior to the date of becoming a sponsor.

The bill requires a barber/cosmetology apprentice to have a written agreement with the sponsor that meets minimum standards as stipulated by the Barbers' Board of Cosmetology. Apprentices are required to have prior written consent from the sponsor in order to provide barber/cosmetology services. The sponsor is required to make certain that the apprentice informs the public that he or she is not a licensed barber or cosmetologist prior to conducting services.

A registration fee cap of \$50 for barber/cosmetology apprentices is authorized and a registration fee cap of \$50 for barber/cosmetology sponsors is specified. The barber/cosmetology sponsor is made responsible for ensuring that the barber/cosmetology apprentice receives training as stipulated by the Barbers' Board or the Board of Cosmetology. The apprentice and sponsor is required to file reports as specified by each relevant board.

The bill provides that if the registered barber/cosmetology apprentice changes sponsors, a new application must be submitted. The bill provides that a barber/cosmetology sponsor must be present at all times in a licensed barbershop or cosmetology salon at any time the apprentice is performing services. If the sponsor cannot attend, the sponsor is allowed, through prior written consent, to appoint a qualified barber/cosmetologist who meets the requirements of the respective board to supervise the apprentice at the licensed barbershop or licensed salon.
