Frederick Douglass Boulevard designated; Department of Transportation to erect suitable markers .--26 27 (1) State Road 915 on N.E. 6th Avenue in Miami-Dade 28 County, from the north boundary of State House District 108 to 29 U.S. 1, is designated as "Frederick Douglass Boulevard." 30 31
