4 Remove everything after the enacting clause and insert:

5 Section 1. Section 287.161, Florida Statutes, is amended
6 to read:

7 287.161 Executive aircraft pool; assignment of aircraft;
8 charge for transportation.--

9 (1) There is created within the Department of Management
10 Services an executive aircraft pool consisting of state-owned
11 aircraft for the purpose of furnishing executive air travel.
12 Such aircraft shall not be a model in excess of a two-engine
13 jet. Aircraft included in the executive aircraft pool may not be
14 specifically assigned to any department or agency on any basis.

15 ~~(2) The Department of Management Services shall charge all~~
16 ~~persons receiving transportation from the executive aircraft~~
