13 Section 1. Paragraph (c) of subsection (1) of section
 14 430.071, Florida Statutes, is amended to read:

15 430.071 Respite for elders living in everyday families.--

17 (c) "Stipend" means an allotment of funds to enable a
 18 diverse population of volunteers to provide services. The
 19 allotment of funds is for a maximum hourly rate that shall not
 20 exceed an amount equal to the federal minimum wage ~~period of~~
 21 ~~service and is not an hourly wage.~~
