The Council was created to enhance accountability of state funding and the effective operation of crime laboratories. The Council also is charged with promoting and coordinating cooperation between the various members of the statewide criminal analysis laboratory system. This bill eliminates the Florida Crime Laboratory Council.

Section 1. Repeals ss. 943.355 and 943.356, F.S., relating to the creation of the Florida Crime Laboratory Council and the duties of the Florida Crime Laboratory Council.

Section 2. Amends s. 943.36, F.S., relating to the submission of an annual budget for the purpose of providing funding to existing laboratories as set out in s. 943.35, F.S.; making conforming changes.

Section 3. Provides an effective date.
