The sum of \$2 million shall be transferred to the 27 Historical Resources Operating Trust Fund for the purpose of 28 funding historic preservation matching grants pursuant to s. 29 267.0617. 30 31

9	Endowment Program as provided in s. 265.606.

11	If proceeds fall below the amounts required to be disbursed in
12	subparagraphs 13., the spending authority provided in this
13	paragraph for the Cultural Institutions Trust Fund and the
14	Historical Resources Operating Trust Fund shall be reduced
15	proportionally.
