6 (57) FLORIDA NATIONAL GUARD LICENSE PLATES.--

7 (a) Notwithstanding the provisions of s. 320.08053, the  
8 department shall develop a Florida National Guard license plate  
9 as provided in this section. The word "Florida" must appear at  
10 the top of the plate, and the words "National Guard" must appear  
11 at the bottom of the plate. The Florida National Guard seal, two  
12 and three-quarters inches in diameter, must appear in the center  
13 of the plate in proper colors.

14 (b) The department shall retain initial annual use fee  
15 proceeds sufficient to cover its costs related to the  
16 development and issuance of the Florida National Guard license

17 | plate, not to exceed \$60,000. The For Giving Foundation, Inc.,

 22 | Foundation, Inc., to fund the Florida National Guard Foundation  
 23 | and Florida faith-based organizations that meet the  
 24 | qualifications of s. 501(c)(3) of the Internal Revenue Code. The  
 25 | For Giving Foundation, Inc., shall distribute the Florida  
 26 | National Guard license plate annual use fees in the following  
 27 | manner:

28 |       1. Up to 5 percent of the funds received by the For Giving  
 29 | Foundation, Inc., shall be expended for administrative costs  
 30 | directly associated with the operations of the foundation. Up to  
 31 | 20 percent of the funds received shall be expended for promotion  
 32 | and marketing of the license plate.

33 |       2. Fifty percent of the funds received by the For Giving  
 34 | Foundation, Inc., shall be distributed to the Florida National  
 35 | Guard Foundation.

36 |       3. Twenty-five percent of the funds received by the For  
 37 | Giving Foundation, Inc., shall be expended to Florida faith-  
 38 | based s. 501(c)(3) organizations.
