(5) (a) Funding for the William L. Boyd, IV, Florida Resident Access Grant Program shall be based on a formula composed of planned enrollment and the state cost of funding undergraduate enrollment at public institutions pursuant to s. 1011.90. The amount of the William L. Boyd, IV, Florida resident access grant issued to a full-time student shall be an amount as specified in the General Appropriations Act. The William L. Boyd, IV, Florida resident access grant may be paid on a 101523

prorated basis in advance of the registration period. After the registration period, the second-term payment may be prorated to allow for a greater award amount in the second term so that the entire amount as specified in the General Appropriations Act is expended. The department shall make such payments to the college or university in which the student is enrolled for credit to the student's account for payment of tuition and fees. Institutions shall certify to the department the amount of funds disbursed to each student and shall remit to the department any undisbursed advances or refunds within 60 days of the end of regular registration. Students shall not be eligible to receive the award for more than 9 semesters or 14 quarters, except as otherwise provided in s. 1009.40(3).
(b) If the combined amount of the William L. Boyd, IV, Florida resident access grant issued pursuant to this act and all other scholarships and grants for tuition or fees exceeds the amount charged to the student for tuition and fees, the department shall reduce the William L. Boyd, IV, Florida resident access grant issued pursuant to this act by an amount equal to such excess.

Section 12. (1) To meet the critical workforce needs of Florida and to maximize the number of diplomas, certificates, and degrees that are awarded to postsecondary education students in fields vital to the citizens of the state, beginning with the 2005-2006 fiscal year, all future enrollment growth funds for state universities, community colleges, and postsecondary workforce education programs shall be appropriated by the Legislature to the Department of Education or to an appropriate 101523

trust fund administered by the department to be distributed according to the provisions of this section.
(2) The department shall develop and issue a request for proposals. In response to the request for proposals:
(a) A proposal may be made by an accredited public or nonpublic postsecondary educational institution in the state that provides postsecondary instruction in a field specified in the priority list established pursuant to subsection (3).
(b) A proposal must indicate the number of postsecondary diplomas, certificates, or degrees that the institution will award using funds received pursuant to this section and the fields in which the diplomas, certificates, and degrees will be awarded.
(c) A proposal must indicate how the funds received will leverage other grants and scholarships and how the funds will be used to offset student tuition costs.
(3) The chair of Workforce Florida, Inc., shall annually by March 1 advise the Legislature of the state's most pressing workforce needs for postsecondary instruction and the geographic locations of these needs. The Legislature shall annually establish a priority list for funds provided pursuant to this section in the General Appropriations Act.
(4) The rankings and decisions of the request for proposal process shall be made by a committee based on the priority list established pursuant to subsection (3). The committee shall be composed of nine members appointed by the Governor subject to confirmation by the Senate. The members shall serve staggered 4year terms. In order to achieve staggered terms, of the initial 101523
