8	Be It Resolved by the Legislature of the State of Florida:

10	That the following amendment to Section 3 of Article XI
11	of the State Constitution, as amended by Revision No. 8
12	(1998), is agreed to and shall be submitted to the electors of
13	this state for approval or rejection at the next general
14	election or at an earlier special election specifically
15	authorized by law for that purpose:
16	ARTICLE XI
17	AMENDMENTS
18	SECTION 3. Initiative
19	(a) The power to propose the revision or amendment of
20	any portion or portions of this constitution by initiative is
21	reserved to the people, provided that, any such revision or
22	amendment, except for those limiting the power of government
23	to raise revenue, shall embrace but one subject and matter
24	directly connected therewith. The amendment or revision must
25	also:
26	(1) seek to alter, amend, or repeal an existing
27	article of or amendment to this constitution;
28	(2) address a fundamental right of a citizen of this
29	state; or
30	(3) seek to create, implement, or otherwise change a
31	basic structure of state government.

1	(b) The initiative power It may be invoked by filing
2	with the custodian of state records a petition containing a
3	copy of the proposed revision or amendment, signed by a number
4	of electors in each of one half of the congressional districts
5	of the state, and of the state as a whole, equal to eight
б	percent of the votes cast in each of such districts
7	respectively and in the state as a whole in the last preceding
8	election in which presidential electors were chosen.
9	BE IT FURTHER RESOLVED that the following statement be
10	placed on the ballot:
11	CONSTITUTIONAL AMENDMENT
12	ARTICLE XI, SECTION 3
13	CONSTITUTIONAL AMENDMENTS AND REVISIONS PROPOSED BY
14	INITIATIVEProposing an amendment to the State Constitution
15	to provide that a constitutional amendment or revision
16	proposed by citizen initiative must alter, amend, or repeal an
17	exiting article or amendment to the State Constitution;
18	address a fundamental right of a citizen of this state; or
19	seek to create, implement, or otherwise change a basic
20	structure of state government.
