Subsection (12) of section 790.06, Florida 16 17 Statutes, is amended to read: 790.06 License to carry concealed weapon or firearm.--18 19 (12) No license issued pursuant to this section shall 20 authorize any person to carry a concealed weapon or firearm 21 into any place of nuisance as defined in s. 823.05; any 22 police, sheriff, or highway patrol station; any detention 23 facility, prison, or jail; any courthouse; any courtroom, except that nothing in this section would preclude a judge 24 25 from carrying a concealed weapon or determining who will carry 26 a concealed weapon in his or her courtroom; any polling place; 27 any meeting of the governing body of a county, public school 28 district, municipality, or special district; any meeting of the Legislature or a committee thereof; the district 29 30 legislative office of any state legislator, if notice is

posted in such a manner as to advise the public; anywhere

within the Capitol, the steps leading to the Capitol, the Historic Capitol, the steps leading to the Historic Capitol, 2 3 the Senate Office Building, the House Office Building, the Knott Building, or a parking garage attached to the Capitol, 4 5 the Historic Capitol, the Senate Office Building, the House 6 Office Building, or the Knott Building, except that nothing in 7 this section would preclude a person licensed to carry a 8 concealed weapon or firearm from securing the weapon or firearm in his or her vehicle in a parking garage attached to 9 10 any of those buildings, or in a convenient manner designated 11 by the Capitol Police; any school, college, or professional athletic event not related to firearms; any school 12 administration building; any portion of an establishment 13 licensed to dispense alcoholic beverages for consumption on 14 the premises, which portion of the establishment is primarily 15 devoted to such purpose; any elementary or secondary school 16 17 facility; any area technical center; any college or university facility unless the licensee is a registered student, 18 19 employee, or faculty member of such college or university and 20 the weapon is a stun gun or nonlethal electric weapon or device designed solely for defensive purposes and the weapon 21 does not fire a dart or projectile; inside the passenger 22 terminal and sterile area of any airport, provided that no 23 24 person shall be prohibited from carrying any legal firearm into the terminal, which firearm is encased for shipment for 25 purposes of checking such firearm as baggage to be lawfully 26 27 transported on any aircraft; or any place where the carrying 28 of firearms is prohibited by federal law. Any person who 29 willfully violates any provision of this subsection commits a misdemeanor of the second degree, punishable as provided in s. 30 31 775.082 or s. 775.083.

10 11	<pre>public notice if the member elects to prohibit the carrying of concealed weapons or firearms on the premises.</pre>
12	- The CS provides for a person licensed to carry a
13	concealed weapon or firearm to secure the weapon or firearm either in their vehicle in a parking garage
14	attached to one of the buildings listed in the CS, or with Capitol Police in a location that is convenient to
15	the public.
