Section 828.12, Florida Statutes, is 17 amended to read: 828.12 Cruelty to animals.--18 19 (1) A person who unnecessarily overloads, overdrives, 20 torments, deprives of necessary sustenance or shelter, or 21 unnecessarily mutilates, or kills any animal, or causes the 22 same to be done, or carries in or upon any vehicle, or 23 otherwise, any animal in a cruel or inhumane manner, commits is guilty of a felony misdemeanor of the third first degree, 24 25 punishable as provided in s. 775.082 or by a fine of not more 26 than \$5,000, or both. 27 (2) A person who intentionally commits an act to any 28 animal which results in the cruel death, or excessive or repeated infliction of unnecessary pain or suffering, or 29 30 causes the same to be done, commits is guilty of a felony of 31 1

1 the second third degree, punishable as provided in s. 775.082 2 or by a fine of not more than \$10,000, or both. 3 (a) A person convicted of a violation of this subsection, where the finder of fact determines that the 4 5 violation includes the knowing and intentional torture or 6 torment of an animal that injures, mutilates, or kills the 7 animal, shall be ordered to pay a minimum mandatory fine of \$5,000, serve a minimum mandatory period of incarceration of 6 8 9 months, \$2,500 and undergo psychological counseling or 10 complete an anger management treatment program. 11 (b) Any person convicted of a second or subsequent violation of this subsection shall be required to pay a 12 minimum mandatory fine of \$5,000 and serve a minimum mandatory 13 period of incarceration of 10 $\frac{6}{6}$ months. In addition, the 14 person shall be released only upon expiration of sentence, 15 shall not be eligible for parole, control release, or any form 16 17 of early release, and must serve 100 percent of the 18 court-imposed sentence.
