This subparagraph is subject to the Open Government Sunset Review Act of 1995 in accordance with s. 119.15, and shall stand repealed on October 2, 2006, unless reviewed and saved from repeal through reenactment by the Legislature.

<u>6.4.</u> An agency that is the custodian of the personal information specified in subparagraph 1., subparagraph 2., or subparagraph 3., subparagraph 4., or subparagraph 5., and that is not the employer of the officer, employee, justice, judge, or other person specified in subparagraph 1., subparagraph 2., or subparagraph 3., subparagraph 4., or subparagraph 5., shall maintain the confidentiality of the personal information only if the officer, employee, justice, judge, other person, or employing agency of the designated employee submits a written request for confidentiality to the custodial agency.

Section 2. The Legislature finds that the exemption from public-records requirements provided for by this act for identifying and locating information relating to current and former United States attorneys, assistant United States attorneys, judges of the United States Courts of Appeal, United States district judges, United States magistrate judges, and their families is a public necessity. This act is justified because, if such information were not confidential, a United States attorney, an assistant United States attorney, a judge of the United States Court of Appeal, a United States district judge, a United States magistrate judge, or his or her family could be harmed or threatened with harm by a criminal defendant or by a friend or family member of a criminal defendant.

Section 3. This act shall take effect October 1, 2004.
