Section 154. (1) The Department of Financial Services shall, no later than November 1, 2004, notify the Department of Business and Professional Regulation of its intention to contract with the Department of Business and Professional Regulation, another governmental agency, or a private business for the implementation of a system for the administration of the overall licensing process, including the processing and tracking of applications for licensure, the issuance of licenses approved by the board, the tracking of licenses issued, the administration of the license renewal process, and the collection and processing of fees relating to those activities. If the Department of Financial Services elects to contract with the Department of Business and Professional Regulation for the services described in this subsection, they
