#### SUMMARY ANALYSIS

Section 334.071, F.S., specifies the purpose and effect of the designation of roads, bridges, and other transportation facilities for honorary or memorial purposes by the Florida Legislature.

# HB 555 designates:

- A portion of State Road 19 in Lake County from the northern boundary at Marion County of U.S. Highway 441 as the "Private Robert M. McTureous, Jr., U.S.M.C., Medal of Honor Memorial Highway."
- The eastbound and westbound spans of the St. Johns River bridge, designated bridge number 790196 and bridge number 790197, on Interstate Highway 4 between Seminole and Volusia Counties as the "St. Johns River Veterans Memorial Bridge."

The Florida Department of Transportation (FDOT) is directed to erect suitable markers to denote the honorary designations. The markers will cost approximately \$ 1,600.00

HB 555 does not create any constitutional issues. It takes effect upon becoming law.

#### B. EFFECT OF PROPOSED CHANGES:

Section 334.071, F.S., provides for legislative designations of transportation facilities for honorary or memorial purposes, or to distinguish a particular facility. The legislative designations do not "officially" change the current names of the facilities, nor does it require local governments and private entities to change street signs, mailing addresses, or 911 emergency telephone-number system listings. The statute requires FDOT to place a marker at each terminus or intersection of an identified road or bridge. and to erect other markers it deems appropriate for the transportation facility. The statute also provides that a city or county must pass a resolution in support of a particular designation before road markers are erected. Additionally, if the designated road segment extends through multiple cities or counties then a resolution must be passed by each affected local government.

Based on FDOT records, 999 honorary road and bridge designations have been approved since 1922, most of them by the Legislature. Some public roads and bridges have multiple or overlapping designations.

HB 555 creates two additional road designations:

- A portion of State Road 19 in Lake County from the northern boundary at Marion County of U.S. Highway 441 as the "Private Robert M. McTureous, Jr., U.S.M.C., Medal of Honor Memorial Highway."
- The eastbound and westbound spans of the St. Johns River bridge, designated bridge number 790196 and bridge number 790197, on Interstate Highway 4 between Seminole and Volusia Counties as the "St. Johns River Veterans Memorial Bridge."

FDOT is direct to erect suitable makers for the designations.

Section 1: Creates an honorary designation of "Private Robert M. McTureous, Jr., in U.S.M.C., Medal of Honor Memorial Highway" in Lake and Marion Counties.

Section 2: Creates an honorary designation of "St. Johns River Veterans Memorial Bridge" in Seminole and Volusia Counties.
