The home addresses, telephone numbers, social security numbers, and photographs of current or former code enforcement officers; the names, home addresses, telephone numbers, social security numbers, photographs, and places of employment of the spouses and children of such persons; and the names and locations of schools and day care facilities attended by the children of such persons are exempt from subsection (1) and s. 24(a), Art. I of the State Constitution. This subparagraph is subject to the Open Government Sunset Review Act of 1995 in accordance with s. 119.15, and shall stand repealed on October 2, 2006, unless reviewed and saved from repeal through reenactment by the Legislature.
- 4. An agency that is the custodian of the personal information specified in subparagraph 1., subparagraph 2., or subparagraph 3. and that is not the employer of the officer, employee, justice, judge, or other person specified in subparagraph 1., subparagraph 2., or subparagraph 3. shall maintain the confidentiality of the personal information only if the officer, employee, justice, judge, other person, or employing agency of the designated employee submits a written request for confidentiality to the custodial agency.

The Legislature finds that the exemption from Section 3. public records requirements provided for by this act for the home addresses, telephone numbers, social security numbers, and photographs of active or former emergency medical technicians or paramedics certified in compliance with chapter 401, Florida Statutes, the home addresses, telephone numbers, social security numbers, photographs, and places of employment of the spouses and the children of such emergency medical technicians and paramedics, and the names and locations of schools and day care facilities attended by children of such emergency medical technicians and paramedics is a public necessity. This exemption is justified because if such information were not confidential, an emergency medical technician or paramedic or a member or members of his or her family could be harmed or threatened with harm by an individual, or a family member of such individual, who was provided emergency medical care which resulted in a negative outcome.

Section 4. This act shall take effect upon becoming a law.
