SUMMARY ANALYSIS

The bill revises the Hillsborough County Public Transportation Commission's (PTC) definition of "limousine" to meet the minimum standards for safety, age, and condition, as established by the Commission in its rules.

The bill also increases the maximum authorized capacity of passengers in a limousine from 15 to 22 people.

According to the economic impact statement, the definition change will result in an indeterminable amount of revenue increase to the PTC, not to exceed \$3,000 annually.

B. EFFECT OF PROPOSED CHANGES:

The Hillsborough County PTC is an independent special district which regulates "for-hire" vehicles such as taxicabs, limousines, handicabs, and ambulances. The PTC is funded by fees charged to regulated industries.

The bill revises the Commission's definition of "limousine" to meet the minimum standards for safety, age, and condition, as established by the Commission in its rules in s. 8.4, Rules of the PTC.

The bill also increases the maximum authorized capacity of passengers in a limousine from 15 to 22 people. According to the economic impact statement, the definition change will result in an indeterminable amount of revenue increase to the commission not expected to exceed \$3,000 annually.

C. SECTION DIRECTORY:

Section 1 amends ss. (17), of s. 3, of Ch. 2001-299, L.O.F., to update the Hillsborough County PTC's definition of "limousine."

Section 2 provides that the bill shall take effect upon becoming a law.
