**I. Summary:**

This legislation re-creates the "Trust Funds-no title" Trust Fund without modification. The "Trust Funds-no title" Trust Fund, FLAIR #44-2-732, is administered by the Department of Financial Services. This fund was last re-created effective November 4, 2000, by Chapter 99-73, Laws of Florida.

**II. Present Situation:**

Section 215.18, F.S., permits the Department of Financial Services to make temporary transfers of moneys from one fund to another in order to meet temporary deficiencies in a particular fund as ordered by the Governor. This fund operates as a cash management account. All monies temporarily transferred are to be repaid no later than the end of the fiscal year in which such transfer is made.

This bill re-creates the trust fund without modification.
