I. Summary:

This legislation re-creates the Workers' Compensation Administration Trust Fund without modification. The Workers' Compensation Administration Trust Fund, FLAIR #43-2-795, is administered by the Department of Financial Services. It was transferred from the Department of Labor and Employment Security by Chapter 2002-194, Laws of Florida. This fund was last re-created effective November 4, 2000, by Chapter 2000-77, Laws of Florida.

II. Present Situation:

Section 440.50, F.S., creates the Workers' Compensation Administration Trust Fund. The revenue sources for this fund are fees, licenses and taxes as provided by Chapter 440, F.S. including an assessment paid by carriers writing workers' compensation insurance in the state and self-insurers. This fund pays for expenses related to the administration of Chapter 440, F.S. According to LAS/PBS data, receipts to this fund for FY 2002-2003 were \$166.9 million.
