SUMMARY ANALYSIS

Section 334.071, F.S., specifies the purpose and effect of the designation of roads, bridges, and other transportation facilities for honorary or memorial purposes by the Florida Legislature.

HB 9 w/CS designates:

- A portion of U.S. Highway 192 from Interstate 95 in Brevard County to St. Cloud in Osceola County as Howard E. Futch Memorial Highway.
- State Road 121 within Baker County as the "Ed Fraser Memorial Highway"
- A portion of Interstate 95 in Nassau County as "Trooper Charles W. Parks Memorial Highway"
- State Road 121 proceeding south from the Union County line to the city limits of the City of Lake Butler as the "Deputy Renee Danell Azure Memorial Highway"
- A portion of Access Road Number 10-030-111 between Gandy Boulevard and the Friendship Trail Bridge (FDOT Number 10-068) in Hillsborough County as the "Andrew J. Aviles Trail"
- A portion of State Road 19 in Lake County, from the north end of Lake County to the intersection of State Road 19 and U.S. Highway 441 in Eustis as the "Private Robert M. McTureous, Jr., U.S.M.C., Medal of Honor Memorial Highway"
- The westbound and eastbound bridges of the replacement for I-4/St. Johns River Bridge as "The St. Johns River Veterans Memorial Bridge"
- The Panasoffkee Bridge (FDOT Number 180940) on I-75 in Sumter County as the "Florida Veterans Memorial Bridge"
- The Interchange of Interstate Highway 95 and State Road 100 at exit number 284 in Flagler County as the "Deputy Charles 'Chuck' Sease Memorial Interchange."

The Florida Department of Transportation (FDOT) is directed to erect suitable markers to denote the honorary designations. The markers will cost approximately \$7,200.00.

HB 9 w/CS does not create any constitutional issues. It takes effect upon becoming law.

B. EFFECT OF PROPOSED CHANGES:

Section 334.071, F.S., provides for legislative designations of transportation facilities for honorary or memorial purposes, or to distinguish a particular facility. The legislative designations do not “officially” change the current names of the facilities, nor does it require local governments and private entities to change street signs, mailing addresses, or 911 emergency telephone-number system listings. The statute requires FDOT to place a marker at each terminus or intersection of an identified road or bridge, and to erect other markers it deems appropriate for the transportation facility. The statute also provides that a city or county must pass a resolution in support of a particular designation before road markers are erected. Additionally, if the designated road segment extends through multiple cities or counties then a resolution must be passed by each affected local government.

Based on FDOT records, 999 honorary road and bridge designations have been approved since 1922, most of them by the Legislature. Some public roads and bridges have multiple or overlapping designations.

HB 9 w/CS designates:

- A portion of U.S. Highway 192 from Interstate 95 in Brevard County to St. Cloud in Osceola County as Howard E. Futch Memorial Highway.
- State Road 121 within Baker County as the “Ed Fraser Memorial Highway”
- A portion of Interstate 95 in Nassau County as “Trooper Charles W. Parks Memorial Highway”
- State Road 121 proceeding south from the Union County line to the city limits of the City of Lake Butler as the “Deputy Renee Danell Azure Memorial Highway”
- A portion of Access Road Number 10-030-111 between Gandy Boulevard and the Friendship Trail Bridge (FDOT Number 10-068) in Hillsborough County as the “Andrew J. Aviles Trail”
- A portion of State Road 19 in Lake County, from the north end of Lake County to the intersection of State Road 19 and U.S. Highway 441 in Eustis as the “Private Robert M. McTureous, Jr., U.S.M.C., Medal of Honor Memorial Highway”
- The westbound and eastbound bridges of the replacement for I-4/St. Johns River Bridge as “The St. Johns River Veterans Memorial Bridge”
- The Panasoffkee Bridge (FDOT Number 180940) on I-75 in Sumter County as the “Florida Veterans Memorial Bridge”
- The Interchange of Interstate Highway 95 and State Road 100 at exit number 284 in Flagler County as the “Deputy Charles ‘Chuck’ Sease Memorial Interchange.”

This bill directs FDOT to erect suitable markers for these designations.

HB 9 w/CS takes effect upon becoming law.

Section 7: Creates an honorary road designation in Volusia and Seminole Counties as the "St. John's River Memorial Bridge." Directs FDOT to erect suitable markers designating the Bridge

Section 8: Creates an honorary road designation in Sumter County as the "Florida Veterans Memorial Bridge." Directs FDOT to erect suitable markers designating the Bridge

Section 9: Creates an honorary road designation for Deputy Charles "Chuck" Sease in Flagler County. Directs FDOT to erect suitable markers designating the Interchange

IV. AMENDMENTS/COMMITTEE SUBSTITUTE CHANGES

At its January 21, meeting the Transportation Committee adopted without objection five amendments to HB 9 that added eight additional road designations to the legislation. The eight additional road designations are:

- State Road 121 within Baker County as the “Ed Fraser Memorial Highway”
- A portion of Interstate 95 in Nassau County as “Trooper Charles W. Parks Memorial Highway”
- State Road 121 proceeding south from the Union County line to the city limits of the City of Lake Butler as the “Deputy Renee Danell Azure Memorial Highway”
- A portion of Access Road Number 10-030-111 between Gandy Boulevard and the Friendship Trail Bridge (FDOT Number 10-068) in Hillsborough County as the “ Andrew J. Aviles Trail”
- A portion of State Road 19 in Lake County, from the north end of Lake County to the intersection of State Road 19 and U.S. Highway 441 in Eustis as the “Private Robert M. McTureous, Jr., U.S.M.C., Medal of Honor Memorial Highway”
- The westbound and eastbound bridges of the replacement for I-4/St. Johns River Bridge as “The St. Johns River Veterans Memorial Bridge”
- The Panasoffkee Bridge (FDOT Number 180940) on I-75 in Sumter County as the “Florida Veterans Memorial Bridge”
- The Interchange of Interstate Highway 95 and State Road 100 at exit number 284 in Flagler County as the “Deputy Charles ‘Chuck’ Sease Memorial Interchange.”

The Committee voted in favor of the bill 21-0, and the bill was reported favorably with a Committee Substitute.

At its March 9, meeting the Subcommittee on Transportation and Economic Development Appropriations recommended without objection four amendments adding four road designations to the legislation. The four additional road designations are:

- A portion of Interstate 4 in Orange County as “Larry E. Smedley Medal of Honor Highway”

- A portion of U.S. Highway 17 in Putnam County as “Jerome A. Williams Memorial Highway”
- The bridge over Sebastian Inlet in Brevard and Indian River Counties (FDOT Number 880005) as “James H. Pruitt Memorial Bridge”
- The Buckhorn Creek Bridge in Wakulla County (FDOT Number 59.005) as the “Arthor L. Andrews Bridge”

On March 16, the Committee on Appropriations adopted the four amendments recommended by the Subcommittee, and reported the bill favorable with committee substitute with a vote of 40Y, 0N.
