On page 25, line 10, through page 26, line 1, delete those lines

and insert:

(c)1. If the kindergarten readiness rate of a private prekindergarten provider or public school falls below the minimum rate adopted by the State Board of Education as satisfactory under s. 1002.69(6), the early learning coalition or school district, as applicable, shall require the provider or school to take certain corrective actions, including the use of a curriculum approved by the department under paragraph (2)(c), and to submit an improvement plan for approval by the coalition or school district, as applicable, and to implement the plan.

2. If a private prekindergarten provider or public school fails to meet the minimum rate adopted by the State Board of Education as satisfactory under s. 1002.69(6) for 2 consecutive years, the early learning coalition or school

1 district, as applicable, shall place the provider or school on
 2 probation. A private prekindergarten provider or public school
 3 that is placed on probation must continue the corrective
 4 actions required under subparagraph 1., including the use of a

 7 Education as satisfactory under s. 1002.69(6).
