#### **SUMMARY ANALYSIS**

Chapter 75-350, L.O.F., governs municipal elections in Broward County, FL. Chapter 75-350, L.O.F., was last amended in 2004 by ch. 2004-443, L.O.F, to change provisions relating to elections dates and qualification periods.

This bill shortens the elections filing period established in ch. 2004-443, L.O.F., by seven days. The new filing period will be from noon on the first work day in January to noon on the  $7^{th}$  day following the first work day in January for elections held in March.

For elections held in <u>November</u>, the new filing period will be from noon on the first work day in September to the 7<sup>th</sup> day following the first work day in September.

The bill changes when primary elections are to be held in Broward County, calling for all <u>primary elections</u> to be held on the Tuesday 9 weeks prior to the corresponding general election.

The bill also clarifies that any November general elections are to be held on the first Tuesday after the first Monday in November.

The bill takes effect upon becoming a law.

#### **FULL ANALYSIS**

## I. SUBSTANTIVE ANALYSIS

#### A. HOUSE PRINCIPLES ANALYSIS:

The bill does not appear to implicate any of the House Principles.

## B. EFFECT OF PROPOSED CHANGES:

#### Background

Chapter 75-350, L.O.F., governs municipal elections in Broward County, FL. Chapter 75-350, L.O.F., was last amended in 2004 by ch. 2004-443, L.O.F, to change provisions relating to elections dates and qualification periods.

According to a report by Patricia A. Bated. City Clerk of the City of Weston, Chapter 75-350, L.O.F was changed because of the cost of running up to 5 elections on an even year (i.e. local primary, local general, presidential primary, statewide primary and statewide general). Public participation in government was adversely affected by the scheduling of local elections and not in the best interest of the community. To realize increased citizen participation in the election process and to facilitate the most cost effective and voter friendly means available a change in the election dates was recommended.

### **Current Provisions**

Currently, ch. 2004-443, L.O.F., provides the following municipal elections provisions:

An election day on the second Tuesday in March of even numbered calendar years.

- For municipal elections in March, the filing period is between noon on the first working day in January and noon on the 14<sup>th</sup> day after the first work day in January.
- A primary election, if needed, is held on the 2<sup>nd</sup> Tuesday in February of even numbered calendar years.

An election day on the second Tuesday in November on even numbered calendar years.

- For municipal elections in November, the filing period is between noon on the first work day in September and noon on the 14<sup>th</sup> day following the first work day September.
- A primary election, if needed, is held on the first Tuesday in October of even numbered calendar years.

## Effect of Proposed Changes

This bill shortens the elections filing period established in ch. 2004-443, L.O.F., by seven days. The new filing period will be from noon on the first work day in January to noon on the 7th day following the first work day in January for elections held in March.

For elections held in November, the new filing period will be from noon on the first work day in September to the 7<sup>th</sup> day following the first work day in September.
