 20 at least 5 years immediately preceding their appointments, have
 21 never been licensed as a health care practitioner under chapter
 22 456 or the applicable practice act, and do not have a
 23 substantial personal, business, professional, or pecuniary
 24 connection with a licensed health care practitioner or with a
 25 medical education or health care facility, except as patients or
 26 potential patients are not, and never have been, licensed health
 27 care practitioners. One member must be a health care risk
 28 manager licensed under s. 395.10974. At least one member of the
 29 board must be 60 years of age or older. The requirements of this
 30 subsection shall be a continuing condition of membership on the
 31 board. Any member who ceases to meet the requirements of this
 32 subsection shall be removed from the board, and a new qualified
 33 member shall be appointed to fill the vacancy for the remainder
 34 of that member's term.

35 Section 2. The requirements of section 458.307, Florida
 36 Statutes, as amended by this act, shall apply to appointments
 37 made on or after the effective date of this act and shall not be
 38 construed to end the term of any member of the Board of Medicine
 39 holding that appointment on the effective date of this act. The
