A bill to be entitled

An act relating to the official Florida Statutes; amending ss. 11.2421, 11.2422, 11.2424, and 11.2425, F.S.; adopting the Florida Statutes 2005 and designating the portions thereof that are to constitute the official law of the state; providing that the Florida Statutes 2005 shall be effective immediately upon publication; providing that general laws enacted during the 2004 regular session and prior thereto and not included in the Florida Statutes 2005 are repealed; providing that general laws enacted during the December 13-16, 2004, special session and the 2005 regular session are not repealed by this adoption act; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 11.2421, Florida Statutes, is amended to read:

11.2421 Florida Statutes 2005 ~~2004~~ adopted.--The accompanying revision, consolidation, and compilation of the public statutes of 2004 ~~2003~~ of a general and permanent nature, excepting tables, rules, indexes, and other related matter contained therein, prepared by the Office of Legislative Services under the provisions of s. 11.242, together with corrections, changes, and amendments to and repeals of provisions of Florida Statutes 2004 ~~2003~~ enacted in additional reviser's bill or bills by the 2005 ~~2004~~ Legislature, is adopted and enacted as the official statute law of the state under the title of "Florida Statutes 2005 ~~2004~~" and shall take effect

30 immediately upon publication. Said statutes may be cited as
 31 "Florida Statutes 2005 ~~2004~~," "Florida Statutes," or "F.S. 2005

33 Section 2. Section 11.2422, Florida Statutes, is amended
 34 to read:

35 11.2422 Statutes repealed.--Every statute of a general and
 36 permanent nature enacted by the State or by the Territory of
 37 Florida at or prior to the 2004 regular ~~August 12-13, 2003,~~
 38 ~~special~~ legislative session, and every part of such statute, not
 39 included in Florida Statutes 2005 ~~2004~~, as adopted by s.
 40 11.2421, as amended, or recognized and continued in force by
 41 reference therein or in ss. 11.2423 and 11.2424, as amended, is
 42 repealed.

43 Section 3. Section 11.2424, Florida Statutes, is amended
 44 to read:

45 11.2424 Laws not repealed.--Laws enacted at the December
 46 13-16, 2004 ~~October 20-24, 2003,~~ Special Session and the 2005
 47 ~~2004~~ regular session are not repealed by the adoption and
 48 enactment of the Florida Statutes 2005 ~~2004~~ by s. 11.2421, as
 49 amended, but shall have full effect as if enacted after its said
 50 adoption and enactment.

51 Section 4. Section 11.2425, Florida Statutes, is amended
 52 to read:

53 11.2425 Rights reserved under repealed statutes.--The
 54 repeal of any statute by the adoption and enactment of Florida
 55 Statutes 2005 ~~2004~~, by s. 11.2421, as amended, shall not affect
 56 any right accrued before such repeal or any civil remedy where a
 57 suit is pending.
