Section 3. For the purpose of incorporating the amendment made to section 386.203, Florida Statutes, in a reference thereto, subsection (1) of section 561.695, Florida Statutes, is reenacted, and subsection (5) of that section is amended, to read:

561.695 Stand-alone bar enforcement; qualification; penalties.--

(1) The division shall designate as a stand-alone bar the licensed premises of a vendor that operates a business that meets the definition of a stand-alone bar in s. 386.203(11) upon receipt of the vendor's election to permit tobacco smoking in the licensed premises.

(5) After the initial designation, to continue to

1 qualify as a stand-alone bar the licensee must provide to the
2 division annually, on or before the licensee's annual renewal
3 date, an affidavit that certifies, with respect to the
4 preceding 12-month period, the following:

5 (a) No more than 10 percent of the gross revenue of
6 the business is from the sale of food consumed on the licensed
7 premises as defined in s. 386.203(11) or, if such licensed
8 premises is in a building that is individually listed in the
9 National Register of Historic Places as defined in s. 267.021,
10 no more than 20 percent of the gross revenue of the business
11 is from the sale of food consumed on the licensed premises.

12 (b) Other than customary bar snacks as defined by rule
13 of the division, the licensed vendor does not provide or serve
14 food to a person on the licensed premises without requiring
15 the person to pay a separately stated charge for food that
16 reasonably approximates the retail value of the food.

17 (c) The licensed vendor conspicuously posts signs at
18 each entrance to the establishment stating that smoking is
19 permitted in the establishment.

22 affidavit required by this subsection.
